## NOTICE OF PUBLIC HEARING

“The Montcalm County Board of Commissioners will hold a public hearing on August 22, 2022 at 4:15 p.m. The purpose of the hearing will be for the public to comment on the proposed budget for the fiscal year ending September 30, 2023. **The property tax millage rate proposed to be levied to support the proposed budget will be a subject of this hearing.** The proposed millage rates to be levied are 4.3066 mills for the County’s general operations, .6500 mills for the maintenance and operation of an Ambulance and Rescue Service, .8818 mills for the purpose of providing funds for local libraries in Montcalm County, .4200 mills for the Commission on Aging for Senior Citizens Services, .1959 mills for Montcalm County Extension & 4-H Program and Montcalm Conservation District, .9799 for the purpose of providing additional Law Enforcement in Montcalm County, .2459 to provide for additional Veterans’ Services in Montcalm County, for a total millage request of 7.6801 mills. A budget total of \$37,530,621 is proposed for fiscal year 2023.

The hearing will be held in the Jack Van Harn Board of Commissioners Room, Third Floor of the Administrative Building, at 211 W. Main Street, Stanton, Michigan. The proposed budget may be examined Monday through Friday at the above address in the Office of the County Controller between 8:00 a.m. and 4:00 p.m. beginning August 12, 2022 or online at [www.montcalmcountymi.gov](http://www.montcalmcountymi.gov).
