No public present at this meeting.


Financial Update

Todd provided a financial update to the board and advised on changes in our tracking system for balances. He advised the board that they are carrying a substantial balance of 45k when yearly spending is around 8k. Todd believes that the assessment should be lowered in 2022 to allow some of the balance to be spent. The board agreed to revisit the balance next year in late summer/early fall to decide what the next year's assessment should be.

Weed Program Update

Steve provided an update on the treatment program. He advised that they are monitoring for starry stonewort, but none has been found so far. This season saw treatments for curly leaf pond weed and milfoil. Jason asked about the possibility of a fluoridone treatment next season. Steve said that Lake Montcalm is one of the clearer lakes overall and he doesn't believe a fluoridone treatment is necessary at this time. He only treated about 12.5 acres of milfoil this season and fluoridone wouldn't be needed until they were closer to 20 acres needing treatment. Steve also brought up percellacore as a possible treatment, if necessary, as it is a cheaper alternative to fluoridone.

There being no further business to come before the Lake Board, a motion was made by Jeff and seconded by Kevin to adjourn the meeting at 10:17 a.m. Motion carried.
